 ITLM Update - As of 12/1/18, 359 ITLMs in 86 unique Veterans' Posts are currently operational. The ITLM Program as a whole has contributed over \$15.8 million in profits to the participating Posts since September 2014.

- 2) Phase II (Prizes over \$600) rolled out at five pilot sites September 13th-14th. Each pilot site received an additional Phase II machine (one site received an additional 2 machines) the week of October 25 for continued testing.
- 3) During the week of November 19, three more posts in western Maryland were added to the pilot program for the Phase II project.

D Responsible Gambling

- 1) Voluntary Exclusion Program
 - a) 22 new participants joined the casino VEP program in November; the current number of active participants is 1,959.
 - b) There were 11 removals from the VEP in November and 268 in total.
 - c) To date, 611 violations have occurred since the casino VEP program began. All have been cited for criminal trespass.
 - d) There were 3 additional enrollments on the lottery VEP list and 3 removals; the total number of participants is 327.
 - e) There are currently 14 participants in the bingo hall VEP program.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) Our Responsible Gambling Coordinator is currently conducting in-person training of Casino Casino Compliance Officers.
- 4) Next MARG meeting will be scheduled for the first quarter of 2019.
