- 1) ITLM Update - As of 4/11/19, 360 ITLMs in 86 unique Veterans' Posts are currently operational. The ITLM Program as a whole has contributed over \$17.6 million in profits to the participating Posts since September 2014.
- 2) The number of posts adding ITLM Phase II (Prizes over \$600) machines continues to increase. There are now 36 posts participating.

D Responsible Gambling

- 1) Voluntary Exclusion Program
 - a) 50 new participants joined the casino VEP program in March; the current number of active participants is 2,090.
 - b) There were 9 removals from the VEP in March and 304 in total.
 - c) To date, 771 violations have occurred since the casino VEP began. All violators are cited for criminal trespass.
 - d) There were 6 additional enrollments on the lottery VEP list and 0 removals; the total number of participants is 345.
 - e) There are currently 15 participants in the bingo hall VEP program.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) The latest MARG meeting was held on April 17 at Ocean Downs.
