- 1) ITLM Update As of 5/8/19, 362 ITLMs in 86 unique Veterans' Posts are currently operational. The ITLM Program as a whole has contributed over \$18.1 million in profits to the participating Posts since September 2014.
- 2) The number of posts adding ITLM Phase II (Prizes over \$600) machines continues to increase. There are now 37 posts participating.

D Responsible Gambling

- 1) Voluntary Exclusion Program
 - a) 48 new participants joined the casino VEP program in April; the current number of active participants is 2,128.
 - b) There were 10 removals from the VEP in April and 314 in total.
 - c) To date, 800 violations have occurred since the casino VEP began. All violators are cited for criminal trespass.
 - d) There were 8 additional enrollments on the lottery VEP list and 2 removals; the total number of participants is 351.
 - e) There are currently 15 participants in the bingo hall VEP program.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) The MLGCA Responsible Gambling Program Director will be conducting a presentation and hosting a resource table at the Maryland Conference on Problem Gambling on 6/14/19.
