CONTRACT MANAGEMENT

- There are 1,229 full-service (PHD and PHDL) and 216 draw game-only (PEX) self-service terminals installed as of December 31.
- A new gemOffice release was delivered and we began UAT testing on December 10.
- Scientific Games began system testing on the new Fast Play games. UAT to follow.

- A network security penetration test was completed on Scientific Games systems to identify vulnerabilities; results were favorable.
- New Keno screens with seasonal themes continue to be developed, approved and deployed. Many have been modified to accommodate the upcoming Keno kicker promotion in which 21 winning numbers are drawn.
- MS Technologies has requested that a number of features be tested prior to installation so that billing can commence.
- As of December 16, 2019, paper applications were no longer accepted from Vendor applicants or Casinos, and all Vendor forms were required to be submitted via the eLicensing system. MLGCA staff are providing assistance to various casinos to help with the new process.

FACILITIES

- Awaiting building management's schedule for closing off the air dampers, repairing the loading dock, replacing warehouse and office lights with LED lighting and painting doors and columns.
- January starts the agency wide Asset / Materials inventory.

WAREHOUSE

The instant ticket warehouse is responsible for packing all of the instant tickets that are shipped to lottery retailers. Orders are placed through the Tel Sell operation, which is operated by our central system vendor. Once an order is placed, it is sent to the warehouse for fulfillment. Additionally, as each new instant game is launched, the majority of retailers receive an initial allocation of the new games to assure the tickets are available across the State. Fulfilled orders are shipped via UPS for next day delivery to retailer locations. In addition to filling the orders, the warehouse is responsible for monitoring UPS to ensure proper billing and timely delivery.
