SUBJECT: Report for the January Commission Meeting

This is a status update of ongoing and special projects in Administration, Finance and Operations.

I. CUSTOMER RESOURCE CENTER

The Customer Resource Center is responsible for processing winner claims. In addition, MGM National Harbor, Live! Casino and Hotel, Hollywood Casino Perryville and Ocean Downs Casino have the ability to cash winning tickets from \$5,001 to \$25,000, similar to our Baltimore claim center. In the near future, our remaining casinos will be provided with the same ability.

The Lottery has approximately **373** Expanded Cashing Authority Program (XCAP) locations that are authorized to cash up to \$5,000 in winnings. In our new system, all claims are processed in the field and the Customer Resource Center no longer has to key in claim forms. These locations, in turn, submit completed claim forms to the Lottery so that the related W-2G can be processed. Data concerning the number and amount of winners' claims processed by the Lottery, the casinos and XCAP retailers are noted below:

IV. PROCUREMENT

• Procurement works closely with all Divisions to support the MLGCA's daily operations including, but not limited to, procurement for printing of POS materials and various information sheets/brochures to support all games; promotional items, sponsorship agreements for events;

- and supplies/equipment for the Lottery's internal use, as well as the processing of all payments under \$5,000 using the State P-Card and monthly reconciliation of bank statements.
- Instant Ticket Games and Related Services Contract (#2013-01) with Pollard Banknote Limited (Primary Contract) and Scientific Games International, Inc. and IGT/GTECH Corporation (both Secondary Contracts) for the production of Instant Tickets and delivery to Retailer locations. These Contracts expire August 31, 2020, with no additional renewal options available. The RFP for a replacement contract has been approved by DGS and the RFP will be issued shortly.
- Central Monitor and Control System for a Video Lottery Terminal Program (#2009-11) with IGT (formerly GTECH Corporation) to provide the design, development, implementation, lease, operation, and maintenance of a complete turnkey Central Monitor and Control System for a Video Lottery Terminal Program. This Contract expires September 26, 2020, with no additional renewal options available. The RFP for a replacement contract has been submitted to DGS for review/approval as required. Approval is still pending and the RFP will be issued upon approval.
- Lottery Central Monitoring and Control System Contract (#2015-01) with Scientific Games Incorporated, Inc.: Modification #1 in the amount of \$579,250 for the term 2/1/2020 6/30/2022 to provide under the Lottery Plus rewards program (1) a license to use the James Bond 007TM imagery, marks and logos for an Instant Ticket Lottery Game, and for supporting marketing materials at Retailer locations selling the tickets, advertising for the tickets, digital materials, and the James Bond Instrumental Theme to promote the game, and (2) related prizes to be awarded to winners of the Instant Ticket game and related second chance promotion. This Modification was approved by the BPW at its 1/8/2020 meeting.
