- 1) ITLM Update - As of 2/13/2020, 375 ITLMs in 88 unique Veterans' Posts are currently operational.
- 2) ITLM sales in January 2020 (\$879,367) increased by 14.1% compared to January 2019 (\$770,563).
- 3) Phase II machines (prizes over \$600) are now offered in 53 posts.

D Responsible Gambling

- 1) Voluntary Exclusion Program
 - a) 51 new participants joined the casino VEP in January; the current number of active participants is 2,382.
 - b) There were 11 removals from the VEP in January and 399 in total.
 - c) To date, 1,000 violations have occurred since the casino VEP began. All violators are cited for criminal trespass.
 - d) There were 5 additional enrollments in the lottery VEP and 1 removal; the total number of participants is 400.
 - e) There are currently 23 participants in the bingo hall VEP. One person was added and one person was removed in January.
- 2) The launch of the new electronic VEP notification process is currently in progress.
