#### **D Responsible Gambling**

- 1) Voluntary Exclusion Program
  - a) 32 new participants joined the casino VEP in February and 16 in March; the current number of active participants is 2,406.
  - b) There were 16 removals from the VEP in February and 8 in March, for a total of 423.
  - c) To date, 1,040 violations have occurred since the casino VEP began. All violators are cited for criminal trespass.
  - d) There were 2 additional enrollments in the lottery VEP in February and 2 in March with 4 removals in February and none in March; the total number of participants is 400.
  - e) There are currently 24 participants in the bingo hall VEP.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) The MARG meeting scheduled for April 15 was postponed and will be rescheduled at a later date.
