- 1) Voluntary Exclusion Program
 - a) 0 new participants joined the casino VEP in April; the current number of active participants is 2,406.
 - b) There were 0 removals from the VEP in April; the current number of removals is 423.
 - c) To date, 1,040 violations have occurred since the casino VEP began. All violators are cited for criminal trespass.
 - d) There were 0 additional enrollments in the lottery VEP in April and 0 removals; the total number of participants is 400.
 - e) There are currently 24 participants in the bingo hall VEP.
- 2) The launch of the new electronic VEP notification process is currently in progress.
