WHEREAS, on June 18, 2015, the Maryland Department of Information Technology approved the award of this Contract to the TO Contractor in the total not to exceed amount of Six Hundred Sixty Thousand Two Hundred Twenty Three Dollars and eighty five cents (\$660,223.85) for the term of approximately five (5) years ending on June 30, 2020;

WHEREAS, on October 10, 2019, the MLGCA approved Modification #1 which, due to operational requirements that had changed during the Contract term, deleted two Priority #6 line items and reallocated the amounts originally associated with those items to the T&M requirements, but did not change the not to exceed ("NTE") amount of the Contract;

WHEREAS, all Functional/Business Requirements (TORFP Section #2.6.3 Functional/Business Requirements (Fixed Price) and ATTACHMENT 1 – Price Sheet, Price Sheet (Summary) - PART A) required in the Contract as specified under the Fixed Price component will be completed by the original contract expiration date, June 30, 2020;

WHEREAS, the MLGCA will have an continuing need for the Ongoing Maintenance and Training (TORFP Section #2.6.4 Additional Optional Requirements (Via Work Order)) services contained in the Contract, and it has therefore been determined that at this time it is in the best interest of the parties to extend this Contract, which otherwise would expire on June 30, 2020, for an additional two-year period solely for Ongoing Maintenance and Training services; and

WHEREAS, the Contractor agrees to this Modification.

NOW, THEREFORE, IN CONSIDERATION OF THE RECITALS, MUTUAL COVENANTS AND PROMISES HEREIN CONTAINED, THE PARTIES HERETO AGREE TO MODIFY THE CONTRACT AS FOLLOWS:

1. The Contract is hereby amended, by mutual agreement of the parties, to be extended for an additional two-year period that will expire on June 30, 2022 for the sole purpose of obtaining Ongoing Maintenance and Training (Work Order) services as defined in Contract/TORFP Section #2.6.4 Additional Optional Requirements (Via Work

Order) and at the Hourly Rates specified in ATTACHMENT 1 – PRICE SHEET: PRICE SHEET (HOURLY RATES) FOR CATS+ TORFP # 2015-08 (PART B) dated 5/26/2015.

- 2. The current total Not to Exceed amount for this Contract #2015-08 is Six Hundred Sixty Thousand Two Hundred Twenty Three Dollars and eighty five cents (\$660,223.85). The amount for this Modification #2 shall not exceed a total of Forty Nine Thousand Nine Hundred Dollars (\$49,900.00) for its 2-year period, resulting in a total contract Not to Exceed amount of Seven Hundred Ten Thousand One Hundred Twenty Three Dollars and eighty five cents (\$710,123.85);
- 3. Except for the terms that have been changed by this Modification #2, all other terms and conditions contained in Contract #2015-08 (as previously amended by Modification #1) are the same and remain unchanged.
- 4. This Modification is subject to approval by any necessary State officials.
