- 1) ITLM Update - As of 8/13/2020, 323 ITLMs in 81 unique Veterans' Posts are currently operational. 8 Posts have remained closed due to various reasons related to the pandemic.

#### **D Responsible Gambling**

- 1) Voluntary Exclusion Program
  - a) 20 new participants joined the casino VEP in June/July; the current number of active participants is 2,394.
  - b) There were 32 removals from the VEP in June/July, for a total of 455.
  - c) To date, 1,084 violations have occurred since the casino VEP began. All violators are cited for criminal trespass.
  - d) There were 3 additional enrollments in the lottery VEP in June/July with 3 removals in June/July; the total number of participants is 400.
  - e) There are currently 22 participants in the bingo hall VEP.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) The MARG meeting scheduled for April 15 was postponed and will be rescheduled at a later date.
