Background

Incredible Technologies, Inc. is an Illinois corporation. Incredible

Technologies, Inc. designs, develops, and manufactures Class II and Class III

electronic gaming devices, including coin-operated video games, and casino

gaming involving video slot, poker and keno content. Incredible Technologies,

Inc. is currently licensed by 30 U.S. state and territorial regulatory gaming

authorities and six Canadian provinces.

Incredible Technologies, Inc. is a privately held company owned by

Elaine A. Hodgson (51%) and Richard A. Ditton (49%). Both Ms. Hodgson

and Mr. Ditton are currently licensed as Principal Employees by the Maryland

Lottery and Gaming Control Commission.

Discussion of Financial Performance

We performed a detailed analysis of Incredible Technologies, Inc.'s

financial condition and operating performance for the years ended December

31, 2015 to 2019 and we offer the following comment and observations:

1) Incredible Technologies, Inc. was found to have financial stability,
