- 1) ITLM Update - As of 12/2/2020, 348 ITLMs in 82 unique Veterans' Posts are currently operational. 6 Posts have remained closed due to various reasons related to the pandemic.

- 2) ITLM sales in November 2020 (\$746,120) decreased by 17.5% compared to November 2019 (\$904,176).

**D Responsible Gambling**

- 1) Voluntary Exclusion Program
  - a) 40 new participants joined the casino VEP in November; the current number of active participants is 2,434.
  - b) There were 11 removals from the VEP in November, for a total of 523.
  - c) To date, 1,226 violations have occurred since the casino VEP began. All violators are cited for criminal trespass.
  - d) There were 8 additional enrollments in the lottery VEP in November with 0 removals; the total number of participants is 417.
  - e) There are currently 33 participants in the bingo hall VEP.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) The 2020 MLGCA employee refresher training on responsible gaming has been distributed to staff.
