- 1) ITLM Update As of 6/9/2021, 371 ITLMs in 86 unique Veterans' Posts are currently operational. 2 Posts are closed due to reasons related to the pandemic.
- 2) ITLMs net sales in May 2021 (\$1,065,707) was an increase of 20.2% compared to May 2019 (\$886,484). (All ITLM locations were closed on March 16, 2020 by the Governor's Executive Order).

### D Responsible Gambling

- 1) Voluntary Exclusion Program
  - a) 32 new participants joined the casino VEP in May; the current number of active participants is 2,482.
  - b) There were 13 removals from the VEP in May, for a total of 619.
  - c) To date, 1,446 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 9 additional enrollments in the lottery VEP in May with 3 removals; the total number of participants is 444.
  - e) There are currently 77 participants in the bingo hall VEP.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) Currently analyzing data from the 2020 MLGCA employee refresher training on responsible gaming.
