#### **D** Responsible Gambling

- 1) Voluntary Exclusion Program
  - a) 28 new participants joined the casino VEP in July; the current number of active participants is 2,480.
  - b) There were 30 removals from the VEP in July, for a total of 672.
  - c) To date, 1,541 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 6 additional enrollments in the lottery VEP in July with 1 removal; the total number of participants is 455.
  - e) There are currently 97 participants in the bingo hall VEP.
- 2) The launch of the new electronic VEP notification process is currently in progress.
- 3) Working on the 2021 responsible gaming webinar.
- 4) Next scheduled MARG meeting will be held virtually on September 8, 2021.
