### D Responsible Gambling

- 1) Voluntary Exclusion Program
  - a) 29 new participants joined the casino VEP in October; the current number of active participants is 2,512.
  - b) There were 20 removals from the VEP in October, for a total of 745.
  - c) To date, 1,632 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 8 additional enrollments in the lottery VEP in October with 0 removals; the total number of participants is 471.
  - e) There are currently 112 participants in the bingo hall VEP.
- 2) Working with the MD Center of Excellence to present a webinar for the holiday campaign in November.
- 3) Reviewing Sports Wagering Responsible Gaming Plans for casinos who have submitted their Sports Wagering license applications.
- 4) Preparing responsible gambling initiatives for the implementation of sports wagering.
