D Responsible Gambling

- 1) Voluntary Exclusion Program
 - a) 23 new participants joined the casino VEP in December; the current number of active participants is 2,524.
 - b) There were 14 removals from the VEP in December for a total of 780.
 - c) To date, 1,683 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 3 additional enrollments in the lottery VEP in December with 1 removal; the total number of participants is 474.
 - e) There are currently 127 participants in the bingo hall VEP.
- 2) MLGCA's Problem Gambling Director is leading a subcommittee exploring initiatives for Problem Gambling Awareness Month 2022.
- 3) Completed review and approval of the Sports Wagering Responsible Gaming Plans for the 5 casinos who commenced Sports Wagering in December.
- 4) The next virtual MARG meeting is scheduled for January 26, 2022.
