- 1) ITLM Update - As of 3/10/2022, 385 ITLMs in 90 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in February 2022 (\$1,079,183) was an increase of 25.8% compared to February 2021 (\$857,961).

D Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 23 new participants joined the casino VEP in February; the current number of active participants is 2,528.
 - b) There were 22 removals from the VEP in February for a total of 827.
 - c) To date, 1,738 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 4 additional enrollments in the lottery VEP in February with 0 removals; the total number of participants is 482.
 - e) There are currently 135 participants in the bingo hall VEP.
- 2) MLGCA's Co-presented webinar with the Center of Excellence, MGM and Ocean Downs for Problem Gambling Awareness Month.
- 3) Reaching out to Sports Wagering Licensees to begin establishing a Sports Wagering VEP program.
- 4) The most recent MARG meeting was conducted on January 26, 2022.
- 5) Currently adjusting the VEP application to accommodate Sports Wagering and Fantasy Competitions.
