- 1) ITLM Update - As of 4/8/2022, 382 ITLMs in 89 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in March 2022 (\$1,251,058) was an increase of 17.5% compared to March 2021 (\$1,065,144). This is a new record for monthly sales.

#### **D Responsible Gambling**

- 1) Voluntary Exclusion Program (VEP)
  - a) 35 new participants joined the casino VEP in March; the current number of active participants is 2,544.
  - b) There were 19 removals from the VEP in March for a total of 846.
  - c) To date, 1,773 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 14 additional enrollments in the lottery VEP in March with 2 removals; the total number of participants is 494.
  - e) There are currently 150 participants in the bingo hall VEP.
- 2) Reaching out to Sports Wagering Licensees and Fantasy Competition Operators to begin establishing a VEP for both.
- 3) Currently preparing for the next MARG meeting, date and time to be announced.
- 4) Adjusting the current VEP application to accommodate Sports Wagering and Fantasy Competitions.
