- 1) ITLM Update As of 6/10/2022, 387 ITLMs in 90 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in May 2022 (\$1,171,066) was an increase of 9.9% compared to May 2021 (\$1,065,707).
- 3) Live! VLT Reduction Extension Request During the January, 2022 Commission meeting, the Commission approved a request for the temporary reduction of 150 VLTs at Live! Casino in order to accommodate renovations and reconfigurations. The project was scheduled to be completed on or about August 15, 2022. Due to delays in the renovations, Live! is requesting to extend the period of temporary VLT reductions until on or about December 31, 2022. Live!'s request letter is included in the Consent Agenda.

D Sports Wagering

1) Hollywood Casino opened its permanent sports wagering facility on June 10, 2022.

E <u>Responsible Gambling</u>

- 1) Voluntary Exclusion Program (VEP)
 - a) 31 new participants joined the casino VEP in May; the current number of active participants is 2,584.
 - b) There were 17 removals from the VEP in May for a total of 873.
 - c) To date, 1,847 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 7 additional enrollments in the lottery VEP in May with 2 removals; the total number of participants is 504.
 - e) There are currently 170 participants in the bingo hall VEP.
- 2) Reaching out to Sports Wagering Licensees and Fantasy Competition Operators to begin establishing a VEP for both.
- 3) A fourth VEP database for Sports Wagering and a fifth database for Fantasy Competitions have been created.
