- 1) ITLM Update - As of 9/7/2022, 394 ITLMs in 91 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in August 2022 (\$1,133,217) increased by 8.5% compared to August 2021 (\$1,044,316).

D Sports Wagering

- 1) Riverboat on the Potomac successfully completed their controlled demonstrations and opened their facility on September 8, 2022.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 41 new participants joined the casino VEP in August; the current number of active participants is 2,645.
 - b) There were 21 removals from the VEP in August for a total of 911.
 - c) To date, 1,945 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 11 additional enrollments in the lottery VEP in August with 4 removals; the total number of participants is 524.
 - e) There are currently 211 participants in the bingo hall VEP.
- 2) Reaching out to Sports Wagering Licensees and Fantasy Competition Operators to begin establishing a VEP for both.
- 3) Currently working with the IT Department to establish SFTP notification sites for sports wagering and fantasy competition notifications.
- 4) Working on annual staff training webinar.

F Temporary Casino Closing

- 1) Ocean Downs Casino will temporarily close on Tuesday, September 27 between midnight and noon to perform an upgrade to their player management system.
