- 1) ITLM Update As of 11/2/2022, 401 ITLMs in 92 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in October 2022 (\$1,151,312) increased by 8.7% compared to October 2021 (\$1,059,456).

### D Sports Wagering

- 1) Long Shots controlled demonstrations for their land-based sports wagering facility is tentatively scheduled for the week of November 14, 2022.
- 2) Commanders' controlled demonstrations for their land-based sports wagering facility is currently pending.

### E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
  - a) 25 new participants joined the casino VEP in October; the current number of active participants is 2,669.
  - b) There were 19 removals from the VEP in October for a total of 940.
  - c) To date, 1,998 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 5 additional enrollments in the lottery VEP in October with 5 removals; the total number of participants is 535.
  - e) There are currently 231 participants in the bingo hall VEP.
- 2) A ShareFile site has been established for sports wagering and Fantasy Competition VEP programs and is now operational.
- 3) The annual staff webinar for responsible gaming has been distributed.
- 4) The next MARG meeting is scheduled for 01/25/23 at Live! Casino & Hotel.
