D. CONTRACT MANAGEMENT

- There are 1,752 full-service (PHD and PHDL) and 242 draw game-only (PEX) self-service terminals installed as of November 30.
- We've been working with Scientific Games on several enhancements to systems used by staff to manage operations.

• eLicensing system updates:

- o Gaming/Wagering Renewal is complete and waiting on the Non-Gaming/Non-Wagering and Principal renewals before being put into production.
- o Non-Gaming/Non-Wagering Renewal and Principal Renewal are both in the final stages and expected to be completed and in production before the end of December.

E. FACILITIES

- Continue to work with auditors on inventory and fleet vehicles
- Working with Sales/Communication for warehouse clean-up
- Material's & Supplies Inventory will be conducted 12/07/2022 & 12/08/2022
- Electrician to install 4 power outlets and run 10 new network connections for RNG room.
- Emergency lights to be installed in RNG room
- Freight evaluator still waiting parts for repair
- Deadbolt lock install in the RNG room
- LED lights to be installed throughout agency starting 10/12/2022

F. INFORMATION TECHNOLOGY

- IT is working with facilities to ensure the readiness of the room for the new Random Number Generator (RNG) systems.
- We continue to move forward with the new inventory system, which should go live at the end of December.
- We completed the installation of the wiring for the new WiFi access points throughout the agency. The new WiFi access points have been installed in both the Lottery and Gaming offices
- We received an order of computers that are being installed in various areas of the agency to complete projects and refresh aging equipment.
- IT and Finance responded to a request from the Maryland Department of IT (DoIT) for a cyber-security budget survey initiative being conducted for all Maryland state agencies.
- IT continues to work with the Internal Auditors to review IT and security compliance.

G. WAREHOUSE

The instant ticket warehouse is responsible for packing all of the instant tickets shipped to lottery retailers. Orders are placed through the Tel Sell operation, which is operated by our central system vendor. Once an order is placed, it is sent to the warehouse for fulfillment. Additionally, as each new instant game is launched, the majority of retailers receive an initial allocation of the new games to assure the tickets are available across the State. Fulfilled orders are shipped via UPS for next day delivery to retailer locations. In addition to filling the orders, the warehouse is responsible for monitoring UPS to ensure proper billing and timely delivery.

All Lottery retailers are authorized to cash winning tickets up to \$600; Expanded Cashing Authority Program (XCAP) retailers can cash tickets up to \$5,000; Winning tickets up to \$25,000 can be cashed without appointments at all Maryland casinos.
