D Sports Wagering

- 1) After successful completion of their controlled demonstrations, Long Shots Frederick opened their land-based sports wagering facility on 11/18/2022.
- 2) Commanders' controlled demonstrations for their land-based sports wagering facility is currently pending.
- 3) The first seven mobile sports wagering licensees commenced operations on 11/23/2022.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 41 new participants joined the casino VEP in November; the current number of active participants is 2,698.
 - b) There were 12 removals from the VEP in November for a total of 952.
 - c) To date, 2,024 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 10 additional enrollments in the lottery VEP in November with 1 removal; the total number of participants is 544.
 - e) There are currently 243 participants in the bingo hall VEP.
 - f) There are currently 6 participants in the sports wagering VEP.
 - g) There are currently 6 participants in the fantasy competition VEP.
- 2) The annual staff webinar for responsible gaming is ongoing.
- 3) The next MARG meeting is scheduled for 01/25/2023 at Live! Casino & Hotel.
