1) As of this date, the Commanders are performing controlled demonstrations for their land-based sports wagering facility with anticipated opening upon a successful completion.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 25 new participants joined the casino VEP in December; the current number of active participants is 2,704.
 - b) There were 19 removals from the VEP in December for a total of 971.
 - c) To date, 2,060 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 7 additional enrollments in the lottery VEP in December with 3 removals; the total number of participants is 548.
 - e) There are currently 250 participants in the bingo hall VEP.
 - f) There are currently 9 participants in the sports wagering VEP.
 - g) There are currently 8 participants in the fantasy competition VEP.
- 2) The next MARG meeting is scheduled for 01/25/2023 at Live! Casino & Hotel.
- 3) The process of hiring an additional staff member for responsible gambling is ongoing.
