- 1) ITLM Update - As of 02/02/2023, 398 ITLMs in 91 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in January 2023 (\$1,260,508) increased by 31.4% compared to January 2022 (\$959,653).

D Sports Wagering

- 1) After successfully completing their controlled demonstration, Maryland Stadium Sub (Washington Commanders) and their platform provider Fanatics, opened their land based operation on January 20, 2023.
- 2) After successfully completing their controlled demonstration, Long Shots and their platform provider BetFred, opened their mobile operation on February 9, 2023.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 25 new participants joined the casino VEP in January; the current number of active participants is 2,714.
 - b) There were 15 removals from the VEP in January for a total of 986.
 - c) To date, 2,082 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 6 additional enrollments in the lottery VEP in January with 3 removals; the total number of participants is 551.
 - e) There are currently 261 participants in the bingo hall VEP.
 - f) There are currently 25 participants in the sports wagering VEP.
 - g) There are currently 21 participants in the fantasy competition VEP.
- 2) A MARG meeting was held on 01/25/2023 at Live! Casino & Hotel.
- 3) The process of hiring an additional staff member for responsible gambling is ongoing.
