- 1) ITLM Update - As of 03/06/2023, 398 ITLMs in 91 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in February 2023 (\$1,234,500) increased by 14.4% compared to February 2022 (\$1,079,183).

**D Sports Wagering**

- 1) Greenmount and their platform provider Parx Interactive along with Superbook are currently scheduled to be the next two mobile sports operators to go live with anticipated dates within the month of March.

**E Responsible Gambling**

- 1) Voluntary Exclusion Program (VEP)
  - a) 25 new participants joined the casino VEP in February; the current number of active participants is 2,724.
  - b) There were 15 removals from the VEP in February for a total of 1,001.
  - c) To date, 2,106 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 4 additional enrollments in the lottery VEP in February with 1 removal; the total number of participants is 554.
  - e) There are currently 269 participants in the bingo hall VEP.
  - f) There are currently 34 participants in the sports wagering VEP.
  - g) There are currently 28 participants in the fantasy competition VEP.
- 2) The next MARG meeting is scheduled for 04/26/23.
- 3) The responsible gambling department added one additional staff member during the month of March.
- 4) The department is currently in the process of performing their annual review of RG plans from the casinos, instant bingo halls, sports wagering operators and daily fantasy contest operators.
