D Sports Wagering

1 Greenmount Station with their platform provider Parx Interactive, along with Superbook are expected to be the next two mobile sports operators to go live with anticipated dates in April.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 54 new participants joined the casino VEP in March; the current number of active participants is 2,747.
 - b) There were 31 removals from the VEP in March for a total of 1,032.
 - c) To date, 2,134 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.

- d) There were 13 additional enrollments in the lottery VEP in March with 2 removals; the total number of participants is 565.
- e) There are currently 289 participants in the bingo hall VEP.
- f) There are currently 56 participants in the sports wagering VEP.
- g) There are currently 50 participants in the fantasy competition VEP.
- 2) The next MARG meeting is scheduled for 04/26/23.
- 3) The responsible gambling department is currently at full staffing level.
- 4) The department is currently in the process of performing their annual review of RG plans from the casinos, instant bingo halls, sports wagering operators and daily fantasy contest operators.
