C Electronic Gaming Device Operations

- 1) ITLM Update As of 06/05/2023, 402 ITLMs in 91 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in May 2023 (\$1,366,855) increased by 16.7% compared to May 2022 (\$1,171,066).

3) Electronic Gaming Device Notifications

Each month, Gaming staff provide a list of software and hardware that has been certified by an approved testing laboratory, and the Commission approves the hardware and software as part of the Consent Agenda. Because the sports wagering industry, especially mobile sports wagering, is dealing with multiple jurisdictions that require the same updates at the same time, the schedule we have operated under is no longer efficient. Beginning with the June Commission meeting, staff will extend the date by which hardware and software must be approved in order to be on the report sent to the Commission each month. Additionally, staff will provide a second list to the Commission on the Tuesday before each meeting with any testing laboratory approvals received up to that time. This will allow a much more timely approval of software and hardware and keep Maryland operating on the most current releases.

D Sports Wagering

1 Greenmount Station, Crab Sports, and VSC are expected to be the next three mobile sports operators to go live with anticipated dates in June and August. Canton Gaming is expected to be the next retail sports operator to go live with an anticipated date in August. Longshots – Frederick is expected to move into its permanent retail sports wagering space in August.

E <u>Responsible Gambling</u>

- 1) Voluntary Exclusion Program (VEP)
 - a) 45 new participants joined the casino VEP in May; the current number of active participants is 2,794.
 - b) There were 12 removals from the VEP in May for a total of 1,069.
 - c) To date, 2,187 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 15 additional enrollments in the lottery VEP in May with 2 removals; the total number of participants is 587.
 - e) There are currently 324 participants in the bingo hall VEP.
 - f) There are currently 92 participants in the sports wagering VEP.

- g) There are currently 84 participants in the fantasy competition VEP.
- 2) The next MARG meeting is scheduled to be held on 08/23/23 at MGM National Harbor.
- 3) The responsible gambling department is currently at full staffing level.
- 4) The department is currently in the process of performing their annual review of RG plans from the casinos, instant bingo halls, sports wagering operators and daily fantasy contest operators.
