D Sports Wagering

1 Greenmount Station launched its mobile sports betting operations on August 10th. VSC is the next mobile sports wagering operator scheduled to go live at the end of August. Whitmans and Canton Gaming are expected to be the next retail sports wagering operators to go live with controlled demonstrations scheduled at the end of August.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 48 new participants joined the casino VEP in July the current number of active participants is 2,868.
 - b) There were 13 removals from the VEP in May for a total of 1,098.
 - c) To date, 2,253 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 13 additional enrollments in the lottery VEP in May with 1 removal; the total number of participants is 618.
 - e) There are currently 365 participants in the bingo hall VEP.
 - f) There are currently 135 participants in the sports wagering VEP.
 - g) There are currently 123 participants in the fantasy competition VEP.
- 2) The next MARG meeting is scheduled to be held on 08/23/23 at MGM National Harbor.
- 3) The responsible gambling department is currently at full staffing level.
- 4) The department is currently in the process of performing their annual review of RG plans from the casinos, instant bingo halls, sports wagering operators and daily fantasy contest operators.
