SUBJECT: Report for the January 2024 Commission Meeting

Following is a status update of ongoing and special projects in the Communications Division:

### **MEDIA RELATIONS**

### **News Coverage:**

More than 75 articles and/or segments on the Maryland Lottery, Maryland's casinos, and/or Maryland's sports wagering program were broadcast and/or published online in the past month by local/regional/industry media outlets including Fox 45, WBAL-TV, WMAR-TV, Fox 45 and WJZ-TV in Baltimore; WTOP; WUSA-TV and Fox 5 in Washington, D.C.; the Maryland Daily Record; the Frederick News-Post; the Hagerstown Herald-Mail; the Cumberland Times-News; and the Salisbury Daily Times.

### **Broadcast Opportunities:**

Communications staff member Doug Lloyd was on the WBAL Radio and 98 Rock pregame shows prior to the Baltimore Ravens games 12/10 and 12/31, and Gail Pelovitz was on both pregame shows prior to the game on 1/6. Doug will be on the pregame shows again prior to the Ravens Divisional Playoff game the weekend of 1/20-21. Doug was on WSMD Radio in Mechanicsville on 12/19 to discuss current games and promotions. Gail did interviews with radio stations WEEG, WAFY and WFRE in Frederick and WQCM in Hagerstown on 12/7; and on WLIF in Baltimore on 12/14 and WZBA in Baltimore on 12/20. Roslyn Lane was on WPOC in Baltimore on 12/8.

Director Martin did an interview with Fox 5 in Washington, D.C., on 1/11 to discuss the most recent sports wagering revenue figures. Director Martin and other Lottery staff are also continuing a series of weekly video conference interviews with Nestor Aparicio for WNST/baltimorepositive.com. The recorded segments are available each Friday.

# Winner Interviews, Lottery News Releases & Video:

Communications staff members conduct interviews with winners of \$30,000 or more who claim their prizes at the Lottery's office. Winners may remain anonymous, but stories include names or photos of winners who give written consent for publicity regarding their prizes. Winner and other lottery-related stories are published on *mdlottery.com*.

Each Monday (or the following day if Monday is a holiday) the Communications staff issues a news release, "The Week in Winners," listing Lottery tickets worth \$10,000 or more that were sold or redeemed in the preceding seven days.

## **Casino and Sports Wagering Information and News Releases:**

Communications staff members write and issue monthly revenue reports on Maryland's casino and sports wagering programs. Information is also regularly posted in the casino and sports wagering sections of *mdgaming.com*.

Communications issued the following casino and sports wagering news releases in the past two months:

### Video

Communications staff member Mike Powell joined the team in November and produces a variety of news and information videos for use on the Lottery's social media platforms and website. In the past month, Mike produced an introductory video; a message on responsible gifting of Lottery tickets during the holiday season; a countdown of the top winners of 2023; and began a series of videos on the Lottery's top recent wins and other news of note.

## **Daily News Headlines:**

Communications staff sent daily news headline emails to Maryland Lottery and Gaming employees and members of the Commission during each day of the five-day workweek. Each email contained links to multiple media articles covering the lottery and gaming industries.
