**D Sports Wagering**

No retail or mobile sports betting launches are currently scheduled.

**E Responsible Gambling**

- 1) Voluntary Exclusion Program (VEP)
  - a) 39 new participants joined the casino VEP in February the current number of active participants is 3,009.
  - b) There were 7 removals from the VEP in February for a total of 1,198.
  - c) To date, 2,435 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 11 additional enrollments in the lottery VEP in February with 2 removals; the total number of participants is 680.
  - e) There are currently 453 participants in the bingo hall VEP.
  - f) There are currently 236 participants in the sports wagering VEP.
  - g) There are currently 218 participants in the fantasy competition VEP.
