E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 45 new participants joined the casino VEP in March. The current number of active participants is 3,038.
 - b) There were 16 removals from the VEP in March for a total of 1,214.

- c) To date, 2,490 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
- d) There were 13 additional enrollments in the lottery VEP in March with 3 removals; the total number of participants is 690.
- e) There are currently 470 participants in the bingo hall VEP.
- f) There are currently 255 participants in the sports wagering VEP.
- g) There are currently 237 participants in the fantasy competition VEP.
