AGENDA ITEM: 2023 Promotional Play Report – Sports Wagering

PRESENTER: James Nielsen, Deputy Director / Chief Operating Officer

ISSUE SUMMARY: In accordance with COMAR 36.10.13.39.G, each sports wagering licensee is required to submit a report of its use of free promotional play during the prior fiscal year and recommend any adjustment to the limitation on free promotional play established in regulation. Current regulation COMAR 36.10.13.39.F states that through the first full fiscal year of a sports wagering licensee's operations, a licensee's proceeds exclude money given away by the licensee as free promotional play and used by bettors to make a sports wager. After the first full fiscal year of a sports wagering licensee's operations, the amount of money given away as free promotional play in a fiscal year may not exceed a percentage of the licensee's proceeds received in the prior fiscal year. The promotional play reports can be found on the MLGCA shared drive under Commission Reports - Nielsen Confidential.
