- 1) ITLM Update - As of 05/09/2024, 407 ITLMs in 92 unique Veterans’ Posts are currently operational.
- 2) Monthly ITLM net sales in April 2024 (\$1,372,720) decreased by 1.1% compared to April 2023 (\$1,387,299).

**D Sports Wagering**

- 1) VSC, with their platform provider Bee-Fee, are expected to be the next mobile sports operator to go live, in May.

**E Responsible Gambling**

- 1) Voluntary Exclusion Program (VEP)
  - a) 47 new participants joined the casino VEP in April. The current number of active participants is 3,060.
  - b) There were 25 removals from the VEP in April for a total of 1,239.
  - c) To date, 2,534 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 11 additional enrollments in the lottery VEP in April with 4 removals; the total number of participants is 697.
  - e) There are currently 485 participants in the bingo hall VEP.
  - f) There are currently 278 participants in the sports wagering VEP.
  - g) There are currently 255 participants in the fantasy competition VEP.
