D Sports Wagering

- 1) VSC, with their platform provider Bee-Fee, completed their controlled demonstration on May 24th and are planning to go live, July 1st.
- 2) Bally's is expected to be the next mobile sports operator to go live, in July.
- 3) Longshot's, retail and mobile platform provider Betfred, notified MLGCA staff that they are ceasing retail and mobile operations on 6/30/24 and 7/31/24, respectively.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 26 new participants joined the casino VEP in May. The current number of active participants is 3.066.
 - b) There were 20 removals from the VEP in May for a total of 1,259.
 - c) To date, 2,574 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 10 additional enrollments in the lottery VEP in May with 6 removals; the total number of participants is 701.
 - e) There are currently 494 participants in the bingo hall VEP.
 - f) There are currently 292 participants in the sports wagering VEP.

g) There are currently 268 participants in the fantasy competition VEP.
