D Sports Wagering

1) Long Shot's is planning to reopen their retail sports book in December 2024. American Wagering is their facility operator.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 40 new participants joined the casino VEP in October. The current number of active participants is 3,182.
 - b) There were 16 removals from the VEP in October for a total of 1,352.
 - c) To date, 2,718 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 15 additional enrollments in the lottery VEP in October with 1 removal; the total number of participants is 753.
 - e) There are currently 563 participants in the bingo hall VEP.
 - f) There are currently 396 participants in the sports wagering VEP.
 - g) There are currently 365 participants in the fantasy competition VEP.
- 2) The annual staff webinar for responsible gambling has been created and deployed.
