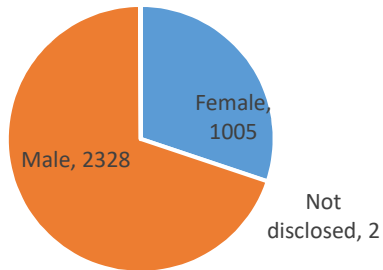

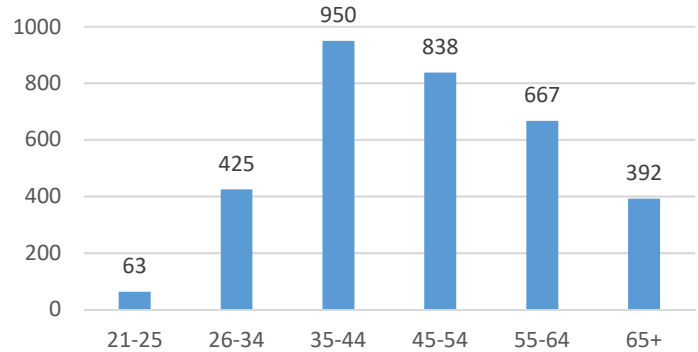

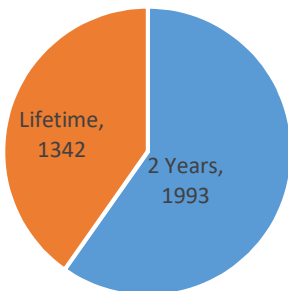
Casino VEP Enrollees By Gender



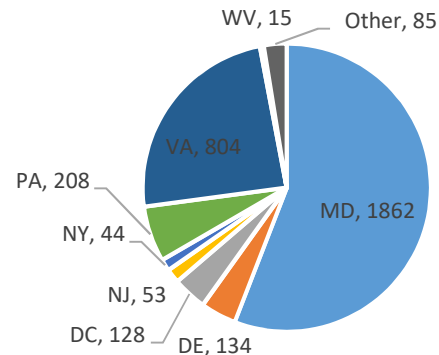
Casino VEP Enrollees By Age
