SUBJECT: Director Report for the January 2026 Commission Meeting

Following is the status update of ongoing efforts in Government Relations, Regulations, and Human Resources for January.

I. GOVERNMENT RELATIONS MATTERS

- A. The Maryland General Assembly convened on Wednesday, January 14, 2026, for the 2026 Legislative Session. MLGCA generates funds for the General Fund, Education Trust Fund, and the Blueprint for Maryland's Future Fund through Lottery, Video Lottery Terminals (Casinos), and Sports Wagering. The Agency's departmental bills will be heard in the House Ways and Means Committee and the Senate Budget and Taxation Committee.

MLGCA has submitted three Departmental Bills (attached):

- Senate Bill 112 (House Bill 295) - Gaming - Prohibition on Illegal Gaming
- Senate Bill 102 (House Bill 291) - Promotional Play - Sports Wagering
- Senate Bill 176 (House Bill 289) - Central Collections Unit Powers - Prize Interception through Video Lottery Operators

These bills will be introduced in the Senate Budget and Taxation Committee by Chair Guy Guzzone and in the House Ways and Means Committee by Chair Jheanelle Wilkins.

- B. The Agency will brief the members of the House Ways and Means Committee on Wednesday, January 21, at 11:00 a.m. This is an early session briefing before this committee.
- C. Budget Briefings: The Agency will have its budget briefings before the following subcommittees:
- Friday, February 13 at 11:30 a.m. before the Senate Budget and Taxation Committee's Public Safety, Transportation, and Environment Subcommittee.
 - Thursday, February 19 at 1:00 p.m. before the House Appropriations Committee's Education and Economic Development Subcommittee

II. REGULATORY MATTERS

October 23, 2025:

- (2) Regulation **.38** under **COMAR 36.03.10 Video Lottery Facility Minimum Internal Control Standards**;

- (4) Regulation **.08** under **COMAR 36.07.06 Technical Standards**;
- (5) Regulation **.01** under **COMAR 36.10.10 Enforcement of Voluntary Exclusion Program**; and
- (6) Regulations **.29** and **.41** under **COMAR 36.10.13 Sports Wagering Licensee Minimum Internal Control Standards**.
