SUBJECT: Report for the June 2026 Commission Meeting

A. eLICENSING

- UVS currently has no open tickets.
- General maintenance is being performed as needed.
- Reviewing possible upgrade to badge printing process.

B. INFORMATION TECHNOLOGY

- The Quarter 2 CY 2026 Information Security Awareness training began in April and is 96% and on track to conclude with 100% completion at the end of June.
- MLGCA IT completed the firewall update at HQ, and has scheduled a replacement of the firewall at the MLGCA Disaster Recovery (DR) Site. Several members of IT recently traveled to the DR site to perform a routine MUSL review and ensure the space was accessible in preparation for the upcoming firewall replacement.
- The IT Department is continuing to coordinate with the Security vendor to complete the installation of the new access control and security system.
- MLGCA IT upgraded several components of the Commission Meeting video conferencing infrastructure, including the replacement of one PC, re-cabling the data lines to the secondary cameras, and installing a backup power system. This improves reliability and functionality during the commission meetings.
- The IT Department is prepared to host the MUSL auditor for their upcoming compliance review.
- MLGCA IT attended a recent statewide cybersecurity roundtable discussion about AI vulnerability management hosted by the Office of Security Management at DoIT.
- Several projects are continuing according to schedule. The Microsoft Office 365 test group has been expanded in preparation for a full agency deployment. The VoIP phone system has been procured and will continue once hardware arrives.

C. PROCUREMENT

The current list of procurements and activities includes:

- MLGCA legislative liaison requested a solicitation for the following report to be completed on or before December 1, 2026:

1. Impacts of the potential expansion of electronic instant bingo machines at commercial electronic instant bingo machine facilities; and
2. Impacts of the potential expansion of electronic instant bingo machines, historical horse racing machines, or underutilized video lottery terminals relative to the limitations under § 9-1A-05(a) of the State Government Article at satellite simulcast facilities that are not located at video lottery facilities or horse racing facilities.

An Invitation for bids is being crafted for publication by the MLGCA.

- The Lottery Central Monitoring and Control System (LCMCS) RFP review with DGS was completed June 9, 2026 and is awaiting final publication.
- Small Procurements – The Procurement team is processing end-of-year purchases to ensure the State's deadline for year-end purchases is met.
- Veterans ITLM – Was submitted to DoIT. This RFP was passed from DoIT to DGS for final review. DGS personnel have contacted MLGCA, no questions have been submitted as of this June 5, 2026.
