Hollywood Casino at Perryville

Underage on casino floor: 0

Intoxicated patrons evicted: 1

On 3/19/15, a male patron was identified as being too intoxicated to remain on the gaming floor and was evicted. 13117

Children unattended in vehicles: 0

Excluded persons in casino: 0

Physical altercations: 1

On 3/29/15, a casino employee was assaulted by an intoxicated subject. The subject had a knife in his hand and touched the employee's arm with it. No injuries were reported. The subject was arrested by PPD. 13380

Theft/Robbery: 1

On 3/29/15, a male subject picked up a jacket that did not belong to him in the Celebrity Bar and Grille. When confronted by a server, the subject left the jacket, and exited the casino. 13381

Drugs: 0

Miscellaneous: 1

On 3/8/15, a male patron was located walking BOH near the kitchen area. It was discovered that the locking system on the rear door was malfunctioning and the subject was able to walk in. The patron was escorted to the main casino and the door lock was repaired. 12775

Casino at Ocean Downs

Underage on casino floor: 1

On 3/27/15, an underage female entered the casino through the main entrance and proceeded to the security desk to obtain an employment application. When approached by security she was identified as being 18 years of age and was evicted. 13345

Intoxicated patrons evicted: 3

On 3/5/15, a female patron along with her male companion were identified as being too intoxicated to remain on the gaming floor and were evicted. They were driven from the property by friends. 12668

On 3/22/15, a female patron was identified as being too intoxicated to remain on the gaming floor and was evicted. 13171

On 3/23/15, a female patron was identified as being too intoxicated to remain on the gaming floor and was evicted. 13208

Children unattended in vehicles: 0

Excluded persons in casino: 0

Physical altercations: 0

Theft/Robbery: 4

On 3/5/15, a male subject was identified as having stolen a voucher from a VLT he did not play on. The subject departed the casino before he could be approached or identified. 12684

On 3/7/15, a patron reported to security that someone had stolen her voucher valued at \$140.00 from a VLT she had been playing. A male suspect was identified and when approached by security he returned the money. 12741

On 3/12/15, a male subject was identified as having stolen \$100.00 from the redemption kiosk that had been left by another patron. When confronted by security he became disorderly and was evicted. The subject's wife made restitution and the money was returned to the owner. 12888

On 3/20/15, a patron dropped cash on the floor without knowing it. A male subject took the money and left the casino. 13151

Underage on casino floor: 1

On 3/26/15, an underage male subject was issued a visitor's badge by security and allowed to enter BOH for the purpose of using the restroom. The subject was to be escorted by a casino employee. The employee failed to escort the underage subject back to the security desk and the underage subject was located on the gaming floor. When confronted by AACOPD and security, the subject was found to be in possession of gaming chips and cash out vouchers. A review by surveillance revealed that the subject did gamble at VLTs and tables while on the floor. As reported by surveillance, no criminal charges were placed against the underage male. 13207

Intoxicated patrons evicted: 1

On 3/1/15, a male subject was identified as being too intoxicated to remain on the gaming floor and was evicted. 12581

Children unattended in vehicles: 0

Excluded persons in casino: 5

On 3/1/15, a male subject who is enrolled in VEP was identified at the cash cage. He was charged with trespass by AACOPD and was evicted. 12585

On 3/5/15, a male subject who is enrolled in VEP was identified at the cash cage. He was charged with trespass by AACOPD and was evicted. 12694

On 3/6/15, a male subject who is enrolled in VEP was identified at Pit 8. He was charged with trespass by AACOPD and was evicted. 12701

On 3/20/15, a male subject who is enrolled in VEP was identified at the cash cage. He was charged with trespass by AACOPD and was evicted. 13150

On 3/29/15, a male subject who is enrolled in VEP was identified in the High Limits area. He was charged with trespass by AACOPD and was evicted. 13421

Physical altercations: 2

On 3/2/15, a female subject assaulted a male subject seated at a table game. The female departed the casino and the male subject left with her. 12600

On 3/29/15, a male subject and a female subject became involved in a physical altercation. The female was arrested by AACOPD.

Theft/Robbery: 10

On 3/5/15, a male subject was identified as having stolen a voucher from a VLT he did not play on. He was approached by security, returned the voucher and was evicted. 12672

On 3/13/15, a male subject was identified as having stolen \$500.00 worth of chips from another patron. The subject was evicted until he could repay the money. 12933

On 3/14/15, a patron reported to security that someone had stolen her voucher valued at \$57.00 from a VLT she had been playing. A suspect was identified and returned the money before being evicted. 12948

On 3/14/15, a patron reported to security that someone had stolen her voucher valued at \$150.00 from a VLT she had been playing. A suspect was identified and returned the money before being evicted. 12950

On 3/15/15, a patron reported to security that someone had stolen her voucher valued at \$217.00 from a VLT she had been playing. A suspect was identified and agreed to return the money before being evicted. 12964

On 3/16/15, a patron reported to security that someone had stolen a voucher from the VLT he had been playing. A suspect was located and evicted. 13016

On 3/22/15, a patron reported to security that he dropped a \$20.00 bill and that a male subject took it and left the casino.

On 3/27/15, a patron reported to security that someone had stolen her cash voucher valued at \$11.86. A suspect was located and evicted. 13350

On 3/29/15, a patron reported to security that someone had stolen her cash voucher valued at \$486.88. A suspect was identified and will be approached upon her return. 13373

On 3/29/15, a patron reported to security that someone had stolen a bag she had sat next to a VLT. A review by surveillance revealed a male subject take the bag into the restroom and leave without it. The patron reported \$900.00 was missing from the bag. 13418

Employee theft: 2

On 3/17/15, MLGCA was notified of an employee termination for theft. 13078

On 3/20/15, MLGCA was notified of two (2) employees being terminated for theft. 13207

Drugs: 1

On 3/27/15, a wallet was found outside of the casino. When security checked it for identification, a quantity of suspected marijuana was found inside. The wallet belonged to a casino table games dealer. The dealer was suspended pending investigation. 13308

Miscellaneous: 3

On 3/2/15, AACOPD recovered a stolen vehicle from the parking garage. 12611

On 3/21/15, a patron dropped a handgun out of his pocket onto the floor near Pit 5. The subject was arrested by AACOPD. 13164

On 3/31/15, a pistol magazine containing ammunition was located in the restroom. AACOPD is investigating. 13461

Rocky Gap Casino

Underage on casino floor: 0

Intoxicated patrons evicted: 9

On 3/1/15, a male subject was identified as being too intoxicated to remain on the gaming floor and was evicted. 12572

On 3/5/15, a male patron was identified as being too intoxicated and disorderly to remain on the gaming floor and was evicted. 12669

On 3/6/15, two male patrons were identified as being too intoxicated and disorderly to remain on the gaming floor and were evicted. 12727

On 3/7/15, a male patron, along with his female companion, were identified as being too intoxicated and disorderly to remain on the gaming floor and were evicted. 12738

On 3/8/15, a male subject was identified as being too intoxicated to remain on the gaming floor and was evicted. 12753

On 3/8/15, a male subject and his female companion were evicted for assaulting a male subject who made a crude comment to the female. The male subject who initiated the assault with his comments was subsequently arrested by MSP. 12745

Theft/Robbery: 8

On 3/3/15, a patron reported to security that someone had stolen her jacket. Contact was made with the suspect and arrangements were made to return the jacket. 12656

On 3/7/15, a patron reported to security that someone had stolen an envelope containing \$400.00 in cash from the area of a VLT she had been playing. A suspect was identified and was approached as she was leaving the casino. The money was returned. 12742

On 3/8/15, a patron reported to security that someone had stolen a voucher valued at \$42.00 from a VLT he had been playing. A suspect was identified and when confronted returned the money. 12759

On 3/14/15, a patron reported to security that someone had stolen a voucher valued at \$42.00 from a VLT she had been playing. A suspect was identified and when confronted returned the voucher. 12955

On 3/22/15, a patron reported to security that someone had stolen a voucher valued at \$46.00 from a VLT he had been playing. A suspect was identified and when confronted returned the money. 13177

On 3/22/15, a patron reported to security that someone had stolen a voucher valued at \$88.10 from a VLT she had been playing. A suspect was identified and when confronted returned the money. 13176

On 3/28/15, a patron reported that another subject was playing on credits she had left in a VLT. The subject was confronted and made restitution. 13365

On 3/30/15, patron reported that another subject was playing on credits he had left in a VLT. The subject was confronted and made restitution. 13432

Drugs: 1

On 3/15/15, a male subject was found to have dropped a cell phone along with a plastic bag containing suspected marijuana. The substance was seized and the subject was given his phone back before being evicted. 12957

Horseshoe Casino

Underage on casino floor: 6

On 3/6/15 two (2) underage male valet employees entered the casino and crossed the gaming floor to use the second floor restroom. They were met by a security supervisor and escorted out of the casino. Neither subject gambled or consumed alcohol. 12734

On 3/8/15, an underage male subject was located on the gaming floor. A review by surveillance revealed that the subject entered the casino using a suspected fraudulent identification, and while on the floor the subject gambled and consumed alcohol. The subject was charged with trespass by BPD and was evicted. 12748

On 3/14/15, an underage female entered the casino using a fraudulent identification card. While on the floor she did consume one (1) alcoholic beverage however she did not gamble. She was charged with trespass by BPD and evicted. 12946

On 3/18/15, an underage female entered the casino using a fraudulent identification card. She was in the casino for approximately 40 minutes before being confronted by security. While on the floor she did not consume any alcohol or gamble. She was charged with trespass by BPD and evicted. 13053

On 3/21/15, two underage male subjects entered the casino by climbing over the barrier into the smoking terrace. They were immediately confronted by security and climbed back over the barrier and ran across the street. Both subjects were evicted and BPD was contacted to charge the subjects with trespass. The subjects did not gamble or consume any alcohol. 13158

On 3/29/15, a driver's license for an underage male subject was located in Pit 5. A review by surveillance revealed that the underage subject who dropped the license had entered the casino unchallenged and gambled at a table game. The subject was on the floor for over an hour and departed the casino without his license. 13455

Intoxicated patrons evicted: 6

On 3/2/15 a male subject was identified as being too intoxicated to remain on the gaming floor and was advised he was being evicted. He became combative, assaulted an EMT and attempted to assault a police officer. He was subsequently arrested. 12610

On 3/5/15, two (2) male subjects were identified as being too intoxicated and disorderly to remain on the gaming floor. Both were evicted. They later returned and caused damage to some signs outside the casino along with one surveillance camera. They departed in a vehicle before security could arrive. 12676

On 3/4/15, a female subject was identified as being too intoxicated to remain on the gaming floor and was evicted. 12682

On 3/12/15, a male subject was identified as being too intoxicated to remain on the gaming floor and was evicted. 12890

On 3/13/15, a male subject was identified as being too intoxicated to remain and in possession of several bottles of liquor while on the gaming floor and was evicted. 12940

On 3/21/15, three (3) male subjects were evicted for being too intoxicated and disorderly to remain on the gaming floor. 13153

Children unattended in vehicles: 0

Excluded persons in casino: 1

On 3/31/15, a male subject who is enrolled in VEP was identified at the cash cage. He was charged with trespass by BPD and was evicted

Physical altercations: 19

On 3/5/15, a male subject and a female subject were involved in a physical altercation in the parking garage. Both were evicted however the female returned later on and was arrested by BPD for trespass. 12675

On 3/7/15, a physical altercation occurred between a patron trying to enter without identification and a security manager. 12737

On 3/7/15, an intoxicated male subject in the poker room assaulted a casino employee and then threw a beer bottle and just missing another employee. The subject was arrested by BPD. 12739

On 3/8/15, two (2) male subjects who were involved in a dispute on the floor were arrested after assaulting a BPD officer. 12756

On 3/10/15, a male subject assaulted a dealer by grabbing her arm. The subject departed the casino prior to security arriving. 12849

On 3/10/15, two (2) chefs in the employee dining room became involved in a dispute at which time one pulled a knife on the other. No injuries were sustained. BPD responded. The subject who pulled the knife was suspended pending investigation. 12850

On 3/10/15, three (3) male subjects and two (2) female subjects were involved in a physical altercation. All subjects were evicted. 12851

On 3/14/15, a male subject was evicted for throwing a chair at another patron. 12941

On 3/14/15, three (3) male subjects became involved in a physical altercation with two (2) of them eventually being arrested by BPD. 12943

On 3/15/15, two (2) female subjects became involved in a physical altercation. One departed on her own and one was evicted. 12965

On 3/15/15, a female patron was evicted for assaulting another patron. 12962

On 3/19/15, several patrons became involved in a physical confrontation at the bar. Two (2) of the participants were evicted. 13082

On 3/22/15, two (2) female subjects became involved in a physical altercation. One was arrested by BPD and the other was evicted. 13181

On 3/21/15, three (3) male subjects became involved in a physical confrontation in the parking garage. 13157

On 3/24/15, a female patron reported that she had been touched in an inappropriate manner by a male subject. BPD responded and the male subject was evicted. 13212

On 3/28/15, two (2) female subjects were involved in a physical altercation. Both were evicted. 13357

On 3/29/15, several subjects became involved in a physical altercation. One male participant was arrested by BPD. 13383

On 3/29/15, two (2) female subjects were involved in a physical altercation. One was evicted and one left on her own. 13384

On 3/29/15, three (3) male subjects were involved in a physical altercation. All subjects were evicted. One later returned and was arrested by BPD for trespass. 13385

Theft/Robbery: 12

On 3/5/15, a male subject was identified as fraudulently using another patron's Total Rewards card and receiving six (6) comps valued at \$84.85. 12670

On 3/6/15, a male subject was identified as having stolen a voucher dropped by another patron. The subject cashed out the voucher and departed the casino. He was identified and an eviction was issued. 12700

On 3/7/15, a male subject was identified as having stolen \$70.00 from another patron at a table game. When confronted by security, he made restitution and was then evicted.

On 3/11/15, a male subject was evicted for possessing and passing counterfeit \$50.00 bills. 12855

On 3/12/15, a male subject was identified as fraudulently using another patron's Total Rewards card in the amount of \$124.10. the subject was evicted. 12889

On 3/13/15, a male subject was identified as having stolen \$800.00 in cash from another patron. The subject returned the money and was evicted. 12939

On 3/21/15, a male subject was identified as having stolen a voucher valued at \$22.50 from another patron. The subject returned the voucher and was evicted. 13178

On 3/25/15, a male subject was evicted for taking a \$25.00 bet off of a table. 13248

On 3/27/15, a subject reported to security that someone had stolen the hubcaps off of his vehicle in the parking garage. A suspect was identified and BPD will pursue theft charges. 13354

On 3/28/15, BPD responded to the casino in reference to recovering a reported stolen vehicle. One arrest was made. 13369

On 3/29/15, a male subject was arrested by BPD for passing and possessing counterfeit currency. 13377

On 3/29/15, a patron reported to security that someone had stolen her cash voucher valued at \$85.37. A suspect was identified and when confronted made restitution. The suspect was evicted. 13382

Drugs: 0

Miscellaneous: 4

On 3/17/15, three (3) females entered the 3rd floor BOH through an unsecure door. They were met by a casino steward who escorted them back to the main casino. The incident was reported to security and the door lock was found to be inoperable. The lock was repaired. 13051

On 3/27/15, a table games shift manager was arrested by BPD on an open warrant. The charges were not related to the casino. 13353

On 3/28/15, a casino employee escorted two (2) females into the casino who were previously denied entry by security for fraudulent identification. 13386

On 3/31/15, a female patron was arrested by BPD on an open warrant that was not related to the casino. 13442
