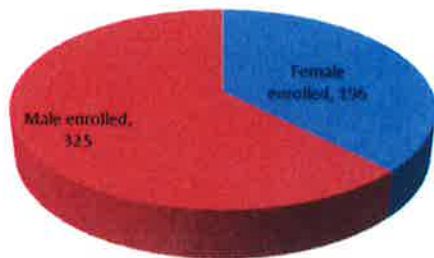
4. Responsible Gambling

a. Voluntary Exclusion Stats

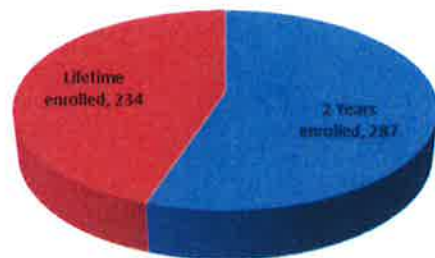
1. The VLT Voluntary Exclusion Program added 28 new participants in May. See attached charts for additional information.

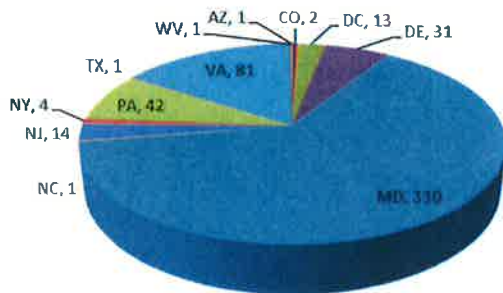
Gender



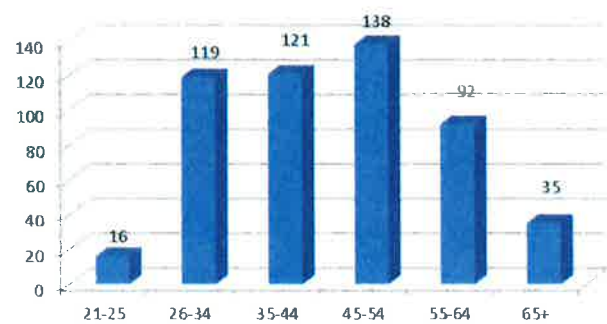
Exclusion Period



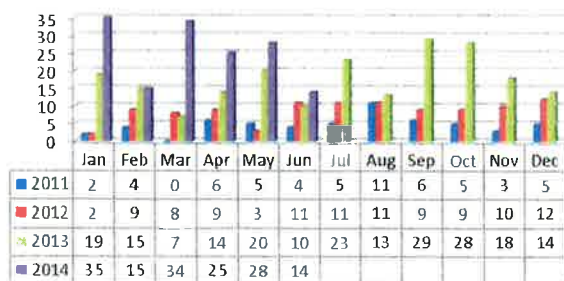
State of Residence



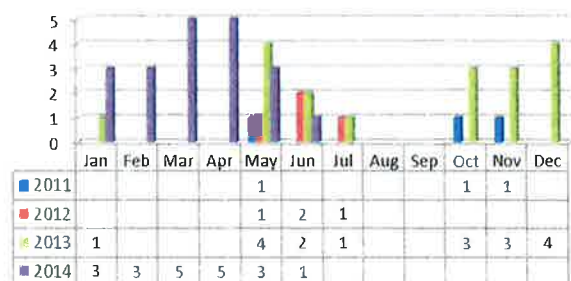
Age
