# CONTRACT MANAGEMENT

• Conversion planning and status meetings continue. Requirements gathering sessions and creation of initial specifications are underway in multiple areas. Development of the paperless application / licensing process and gemIntelligence (Sales Force Automation) have advanced far enough that demonstrations were provided to allow for discussion and a visual depiction of open decision items. Initial terminal counts by type of terminal have been determined. Retailer training and installation dates

were agreed upon. Retailer training will commence the week of October 30. Retailer terminal installations will commence the week of November 6. Additional subscription offerings have been agreed upon. In addition to Mega Millions and Multi-Match, Powerball and Cash4Life will be made available for subscription play.

• MS Technologies continues to work on e-Licensing Systems improvements. An initial group of Priority 6 changes have been released for testing.

# **FACILITIES**

- Building management has identified a number of changes to the HVAC system to address temperature fluctuations and reviewing bids for the equipment needed. Painting has begun, and is occurring after business hours. Carpet replacement will be started once the paining has been completed.
- Staff continue working with IT to develop the capability to use bar-coded labels and a scanner to automate our equipment inventory process.
- An agency-wide physical inventory was just completed and signoffs from each department are being obtained.

# WAREHOUSE

The instant ticket warehouse is responsible for packing all of the instant tickets that are shipped to lottery retailers. Orders are placed through our Tel Sell operation which is operated by our central system vendor. Once an order is placed, it is sent to the warehouse for fulfillment. Additionally, as each new instant game is launched, the majority of retailers receive an initial allocation of the new games to assure the tickets are available across the State. Fulfilled orders are shipped via UPS for next day delivery to the retailer locations. In addition to filling the orders, the warehouse is responsible for monitoring UPS to ensure proper billing and timely delivery.
