C. Responsible Gambling

- a. Voluntary Exclusion Stats
 - 1. The VLT Voluntary Exclusion Program added 27 new participants in December bringing the total participants to 686. See attached charts for additional information.
 - 2. The Lottery Voluntary Exclusion Program added 4 new participants in December bringing the total participant to 85. See attached charts for additional information.
 - 3. There were 5 VEP violators found on properties in December who were cited for criminal trespass, court action pending.
- b. Staff visited 4 Bingo Halls in Anne Arundel County to bring responsible gambling materials and meet with Bingo facility managers. The Bingo Hall training video is targeted for release in February 2015.
- c. The Maryland Alliance for Responsible Gambling Meeting was held on December 18th at the Horseshoe Casino. It was very well attended by all the casinos and pertinent community and state agencies. To date this partnership has been successful in our goal of promoting responsible gambling in the state.
