Live! Casino and Hotel is committed to providing the highest standards of customer care and an exciting entertainment gaming venue. In our continued pledge to our patrons, we will continue to

ensure the safety of patrons and equipment from inclement/severe weather.

- Power and data feeds to extend from the furthest wall/ceiling location and be mounted on the wall perpendicular to the proposed machine configuration, inside of Slot bases, above floor and hidden from elements and patrons
- Materials used will be of outdoor type and quality to prevent elemental interference and orientation/placement to deter tampering
- During monitored weather activity, covers designed for video lottery terminals and chairs
  will be used, placing the video lottery terminals out of service or a combination of the
  two in case of rain, sleet, snow, ice collection or other abnormal weather events
- Designated video lottery terminals will be a part of and undergo a cyclic Preventative
  Maintenance Program that is currently in use for the rest of the floor to ensure complete
  operations and frequent inspection of all facets of the units to verify full operational
  readiness and material conditioning.
