Key accomplishments last period:

News Articles:

More than 15 articles on the Maryland Lottery and/or Maryland's casinos were published in the past month by local/regional/industry publications and on news/blog websites, including the Baltimore Sun, Baltimore Business Journal, The Daily Record and more.

Winner Interviews and News Releases:

Communications staff interviewed more than 20 winners of \$20,000 or more in the past month. News releases were written on those winners and were posted on the Lottery website and/or sent to the media.
