- iv. Worked with Staff on the Agency's 2017 legislative initiatives.

- i. Work with Staff as needed on implementing any new legislation that impacts the Agency.
- ii. Edward M. Jones, et al. v. Gordon Medenica, et al, Circuit Court of Maryland for Baltimore City, Case No.: 24-C-17-002701. Plaintiffs are representing themselves in this action, in which they sue the Director, MLGCA, and Horseshoe Baltimore Casino regarding whether a Racetrax ticket was properly processed by the retailer and the Lottery. The OAG will be filing various dispositive motions in an attempt to end the litigation quickly. A trial date has not been scheduled.

- vii. Worked with Staff on review and revision of the Rules for the Mega Millions and Cash 4 Life games.
- viii. Assisted Staff in preparing the Lottery drawings RFP for release.
