6 **Chapter .14 Three Card Poker Rules**

7 **Authority: State Government Article, §§ 9-1A-02(b), 9-1A-04(d), Annotated Code of**
8 **Maryland**

9 **01. Definitions.**

10 A. In this chapter the following terms have the meaning indicated.

11 B. Terms Defined.

12 (1) "Envy Bonus" means an additional fixed sum payout made to a player who placed a
13 Progressive Payout Wager when another player at the Three Card Poker table is the
14 holder of an Envy Bonus Qualifying Hand.

15
16 (2) "Envy Bonus Qualifying Hand" means a player's Three Card Poker hand of an ace,
17 king and queen of the same suit.

18
19 (3) "Hand" means a Three Card Poker hand that is held by each player and the dealer
20 after the cards are dealt.

21
22 (4) "Pair Plus Wager" means a wager that a player is required to make prior to any cards
23 being dealt to compete against a posted payable, regardless of the outcome of the
24 player's hand against the dealer's hand.

25
26 (5) "Play Wager" means an additional wager that a player shall make if the player opts to
27 remain in competition against the dealer after the player reviews his hand.

28
29 (6) "Progressive Payout Hand" means a player's Three Card Poker hand with a rank of a
30 three-of-a-kind or better or a straight or better depending on the payable selected by the
31 facility operator.

32 **02. Three Card Poker Tables.**

The proposed amendments to this chapter would update the regulations for changes to the rules of play and paytables for the Six Card Bonus identified by the owner of the game and related wagering.

1 A. Three Card Poker shall be played at a table having betting positions for no more than seven
2 players on one side of the table and a place for the dealer on the opposite side of the table.

3 B. The layout for a Three Card Poker table shall be submitted to the Commission for approval
4 and contain at least:

5 (1) The name or logo of the facility operator;

6 (2) Three separate betting areas designed for the placement of Ante, Play and Pair Plus
7 Wagers for each player;

8 (3) If a facility operator offers the optional Progressive Payout Wager authorized under
9 Regulation .07 of this chapter, a separate area designated for the placement of the
10 Progressive Payout Wager for each player;

11 (4) If a facility operator offers the optional Six Card Bonus Wager authorized under
12 Regulation .07 of this chapter, a separate area designated for the placement of the Six
13 Card Bonus Wager for each player; and

14 (5) Inscriptions that advise players of the payout odds or amounts for all permissible
15 wagers offered by the facility operator and the phrase "Dealer Plays with Queen High or
16 Better," except that if payout odds or amounts are not inscribed on the layout, a sign
17 indicating the payout odds or amounts for all permissible wagers shall be posted at each
18 Three Card Poker table.

19 C. If a facility operator offers a Progressive Payout Wager in accordance with Regulation .07 of
20 this chapter, the Three Card Poker table shall have a progressive table game system for the
21 placement of Progressive Payout Wagers that includes:

22 (1) A wagering device at each betting position that acknowledges or accepts the
23 placement of the Progressive Payout Wager; and

24 (2) A device that controls or monitors the placement of Progressive Payout Wagers at the
25 gaming table, including a mechanism, such as a lock-out button, that prevents the
26 recognition of any Progressive Payout Wager that a player attempts to place after the
27 dealer has announced "no more bets."

28 D. A Three Card Poker table shall have a:

- 1 (1) Drop box and tip box attached on the same side of the gaming table as, but on
2 opposite sides of, the dealer, as approved by the Commission; and
- 3 (2) Discard rack securely attached to the top of the dealer's side of the table.
- 4 E. The Commission may approve an alternative location for the tip box when a card shuffling
5 device or other table game equipment prevents the placement of the drop box and tip box on the
6 same side of the gaming table as, but on opposite sides of, the dealer.

7 **03. Cards; Number of Decks.**

8 A. Except as provided in § B of this regulation:

- 9 (1) Three Card Poker shall be played with one deck of cards;
- 10 (2) The cards of a deck shall be identical in appearance; and
- 11 (3) A deck shall contain one cover card.

12 B. If an automated card shuffling device is utilized, Three Card Poker may be played with two
13 decks of cards that meet the following requirements:

- 14 (1) The cards in each deck shall be of the same design;
- 15 (2) The backs of the cards in one deck shall be of a different color than the cards in the
16 other deck;
- 17 (3) One deck of cards shall be shuffled and stored in the automated card shuffling device
18 while the other deck is being used to play the game;
- 19 (3) Both decks are continuously alternated in and out of play, with each deck being used
20 for every other round of play; and
- 21 (4) The cards from only one deck may be placed in the discard rack at any given time;

22 C. The decks of cards used in Three Card Poker shall be changed at least every:

- 23 (1) Four hours if the cards are dealt by hand.

1 (2) Eight hours if the cards are dealt from a manual or automated dealing shoe.

2 **04. Opening a Table for Gaming.**

3 A. After receiving one or more decks of cards at the table, the dealer shall inspect the cards for
4 any defects and a floorperson assigned to the table shall verify the inspection.

5 B. After the cards are inspected, the dealer shall spread out the cards face up, in horizontal fan
6 shaped columns by deck according to suit and in sequence, on the table for visual inspection by
7 the first player to arrive at the table.

8 C. After the first player arriving at the table has been afforded an opportunity to visually inspect
9 the cards, the dealer shall:

10 (1) Turn the cards face down on the table;

11 (2) Mix the cards thoroughly by washing them; and

12 (3) Stack the cards.

13 D. After the cards have been stacked, the cards shall be shuffled in accordance with Regulation
14 .05 of this chapter.

15 E. If an automated card shuffling device is utilized and two decks of cards are received at the
16 table, each deck of cards shall be spread for inspection, mixed, stacked and shuffled in
17 accordance with §§ A – C of this regulation.

18 F. If the decks of cards received at the table are preinspected and reshuffled, §§ A – D of this
19 regulation do not apply.

20 **05. Shuffling and Cutting the Cards.**

21 A. Unless the cards were reshuffled, the dealer shall shuffle the cards so they are randomly
22 intermixed, manually or with an automated card shuffling device:

23 (1) Immediately prior to commencement of play;

24 (2) After each round of play has been completed; or

- 1 (3) When directed by the floorperson or above.
- 2 B. Upon completion of the shuffle, the dealer or automated shuffling device shall place the deck
3 of cards in a single stack.
- 4 C. The facility operator may use an automated card shuffling device which, upon completion of
5 the shuffling of the cards, inserts the stack of cards directly into a dealing shoe.
- 6 D. The deck shall be removed from the table:
- 7 (1) If an automated card shuffling device is being used which counts the number of cards
8 in the deck after the completion of each shuffle and indicates whether 52 cards are
9 present; and
- 10 (2) Automated card shuffling device reveals that an incorrect number of cards are present.
- 11 E. After the cards have been shuffled and stacked, the dealer shall:
- 12 (1) If the cards were shuffled using an automated card shuffling device, deal the cards in
13 accordance with Regulation .08, .09 and .10 of this chapter; or
- 14 (2) If the cards were shuffled manually or were preshuffled, cut the cards in accordance
15 with the procedures in § F of this regulation.
- 16 F. If a cut of the cards is required, the dealer shall place the cover card in the stack at least ten
17 cards in from the top of the stack.
- 18 (1) After the cover card has been inserted, the dealer shall take all cards above the cover
19 card and the cover card and place them on the bottom of the stack.
- 20 (2) The stack of cards shall then be inserted into the dealing shoe for commencement of
21 play.
- 22 G. After the cards have been cut and before any cards have been dealt, a floorperson or above
23 may require the cards to be recut if the floorperson determines that the cut was performed
24 improperly or in any way that might affect the integrity or fairness of the game.
- 25 H. If there is no gaming activity at a Three Card Poker table which is open for gaming, the dealer
26 shall:

- 1 (1) Remove the cards from the dealing shoe and discard rack;
- 2 (2) Unless a player requests that the cards be spread face up on the table, spread out the
3 cards on the table face down; and
- 4 (3) After the first player arriving at the table is afforded an opportunity to visually inspect
5 the cards, complete the procedures in Regulation .04 of this chapter.

6 I. A facility operator may utilize a dealing shoe or other device that automatically reshuffles and
7 counts the cards provided that the device is submitted to the Commission and approved prior to
8 its use in the facility.

9 J. If a facility operator is utilizing a device approved under § I of this regulation, §§ F - H of this
10 regulation do not apply.

11 **06. Three Card Poker Rankings.**

12 A. In order of highest to lowest rank, the rank of the cards used in Three Card Poker is: ace, king,
13 queen, jack, 10, 9, 8, 7, 6, 5, 4, 3 and 2.

14 B. Notwithstanding § A of this regulation, an ace may be used to complete a straight flush or a
15 straight with a 2 and 3 but may not be combined with any other sequence of cards.

16 C All suits are equal in rank.

17 D. In order of highest to lowest rank, the permissible Poker hands in the game of Three Card
18 Poker are:

19 (1) A straight flush, which is a hand consisting of three cards of the same suit in
20 consecutive ranking, with an ace, king and queen being the highest ranking straight flush
21 and an ace, 2 and 3 being the lowest ranking straight flush;

22 (2) A three-of-a-kind, which is a hand consisting of three cards of the same rank with
23 three aces being the highest ranking three-of-a-kind and three 2s being the lowest ranking
24 three-of-a-kind;

25 (3) A straight, which is a hand consisting of three cards of more than one suit and of
26 consecutive rank, with an ace, king and queen being the highest ranking straight and an
27 ace, 2 and 3 being the lowest ranking straight;

1 (4) A flush, which is a hand consisting of three cards of the same suit, regardless of rank;
2 and

3 (5) A pair, which is a hand consisting of two cards of the same rank, with two aces being
4 the highest ranking pair and two 2s being the lowest ranking pair.

5 E. When comparing two Poker hands that are of identical rank under § B of this regulation, or
6 contain none of the hands listed in § B of this regulation:

7 (1) The hand that contains the highest ranking card under § A of this regulation which is
8 not contained in the other hand is the higher ranking hand; or

9 (2) If the hands are of equal rank after the application of this section, the hands shall be
10 considered a tie.

11 F. If a facility operator offers the optional Six Card Bonus Wager under Regulation .07 of this
12 chapter, the five-card Poker hands eligible for a payout are:

13 (1) A royal flush, which is a hand consisting of an ace, king, queen, jack and 10 of the
14 same suit;

15 (2) A straight flush, which is a hand consisting of five cards of the same suit in
16 consecutive ranking;

17 (3) A four-of-a-kind, which is a hand consisting of four cards of the same rank, regardless
18 of suit;

19 (4) A full house, which is a hand consisting of three-of-a-kind and a pair;

20 (5) A flush, which is a hand consisting of five cards of the same suit;

21 (6) A straight, which is a hand consisting of five cards of consecutive rank, regardless of
22 suit;

23 (7) A three-of-a-kind, which is a hand consisting of three cards of the same rank,
24 regardless of suit; or

1 (8) A Super Royal, if the facility operator selects Paytable E in Regulation .12 of this
2 chapter, which is a six-card Poker hand consisting of an ace, king, queen, jack, 10 and 9
3 of the same suit.

4 **07. Wagers.**

5 A. A player shall make a wager at Three Card Poker by placing a value chip, plaque or other
6 Commission-approved table game wagering instrument on the appropriate areas of the table
7 layout.

8 B. Verbal wagers accompanied by cash may not be accepted.

9 C. Only a player who is seated at a Three Card Poker table may place a wager at the game.

10 (1) After a player has placed a wager and received cards, the player shall remain seated
11 until the completion of the round of play.

12 (2) If a player leaves the table during a round of play, a wager made by the player may be
13 considered abandoned and may be treated as a losing wager.

14 C. Except a Play Wager, a wager shall be placed prior to the dealer announcing “no more bets”
15 in accordance with the dealing procedures in Regulations .08, .09 and .10 of this chapter.

16 D. Except as provided in Regulation .11 of this chapter, a wager may not be made, increased or
17 withdrawn after the dealer has announced “no more bets.”

18 E. The following wagers may be placed in the game of Three Card Poker:

19 (1) A player may compete solely against the dealer’s Three Card Poker hand by placing
20 an Ante Wager then a Play Wager in accordance with Regulation .11 of this chapter in an
21 amount equal to the player’s Ante Wager;

22 (2) A player may compete solely against a posted payable by placing a Pair Plus Wager;

23 (3) A player may compete against both the dealer’s Three Card Poker hand and the
24 posted payable by placing an Ante Wager and a Pair Plus Wager in accordance § E(1)
25 and (2) of this regulation;

1 (4) If specified in its Rules Submission, a facility operator may offer to each player at a
2 Three Card Poker table the option to make an additional Progressive Payout Wager that
3 the player will receive a Progressive Payout Hand.

4 (a) After placing an Ante Wager or a Pair Plus Wager, or both, a player may make
5 the additional Progressive Payout Wager by placing a value chip onto the
6 progressive wagering device designated for that player.

7 (b) A player shall be responsible for verifying that the player's respective
8 Progressive Payout Wager has been accepted.

9 (5) If specified in its Rules Submission, a facility operator may offer to each player at a
10 Three Card Poker table the option to make an additional Six Card Bonus Wager that the
11 three cards dealt to the dealer and the three cards dealt to the player will form a five-card
12 Poker hand with a rank of a three-of-a-kind or better.

13 (a) If the facility operator has selected Paytable E in Regulation .12 of this
14 chapter, the three cards dealt to the dealer and the three cards dealt to the player
15 shall be used to form a six-card Poker hand for purposes of the Super Royal
16 payout.

17 (b) After placing an Ante Wager and a Pair Plus Wager, or both, a player may
18 make the additional Six Card Bonus Wager by placing a value chip on the
19 designated betting area prior to the dealer announcing "no more bets."

20 F. Notwithstanding § D(1) – (3) of this regulation, a facility operator may offer a version of
21 Three Card Poker that requires:

22 (1) As a precondition to the placement of a Pair Plus Wager, the placement of an Ante
23 Wager in an amount equal to or greater than the Pair Plus Wager;

24 (2) As a precondition to the placement of a Pair Plus Wager, the placement of an Ante
25 Wager in an amount equal to at least 1/2 the Pair Plus Wager; or

26 (3) The compulsory placement of an Ante Wager and a Pair Plus Wager, provided that
27 one wager may be placed in an amount up to a maximum of five times the amount of the
28 other wager without regard to which wager is the greater of the two.

1 G. A facility operator shall specify in its Rules Submission the number of adjacent boxes on
2 which a player may place a wager in one round of play.

3 **08. Procedure for Dealing Cards from a Manual Dealing Shoe.**

4 A. If a manual dealing shoe is used, the dealing shoe shall be located on the table in a location
5 approved by the Commission.

6 B. After the procedures required under Regulation .05 of this chapter have been completed, the
7 stacked deck of cards shall be placed in the dealing shoe by the dealer or by an automated card
8 shuffling device.

9 C. Prior to dealing any cards, the dealer shall announce “no more bets.”

10 (1) If the Progressive Payout Wager is being offered, the dealer shall use the progressive
11 table game system to prevent the placement of any additional Progressive Payout
12 Wagers.

13 (2) If any Progressive Payout Wagers have been made, the dealer shall:

14 (a) Collect the wagers;

15 (b) On the layout in front of the table inventory container, verify that the number
16 of value chips wagered equals the number of Progressive Payout Wagers accepted
17 by the progressive table game system; and

18 (c) Place the value chips into the table inventory container.

19 D. Each card shall be removed from the dealing shoe with the hand of the dealer that is closest to
20 the dealing shoe and placed on the appropriate area of the layout with the opposite hand.

21 E. Starting with the player farthest to the dealer’s left and continuing around the table in a
22 clockwise manner, the dealer shall deal the cards face down, and:

23 (1) One card at a time to each player who has placed a wager in accordance with
24 Regulation .07 of this chapter and to the dealer until each player who placed a wager and
25 the dealer have three cards; and

1 (2) After three cards have been dealt to each player and the dealer, the dealer shall
2 remove the stub from the manual dealing shoe and, except as provided in § F of this
3 regulation, place the stub in the discard rack without exposing the cards.

4 F. If an automated card shuffling device described in Regulation .05D(1) of this chapter is not
5 being used, the dealer shall count the stub at least once every 5 rounds of play to determine if the
6 correct number of cards are still present in the deck by counting the cards face down on the
7 layout.

8 G. If the count of the stub indicates that 52 cards are in the deck, the dealer shall place the stub in
9 the discard rack without exposing the cards.

10 H. If the count of the stub indicates that the number of cards in the deck is incorrect, the dealer
11 shall determine if the cards were misdealt.

12 (1) If the cards were misdealt but 52 cards remain in the deck, all hands are void and all
13 wagers shall be returned to the players.

14 (2) If the cards were not misdealt, all hands are void, all wagers shall be returned to the
15 players and the entire deck of cards shall be removed from the table.

16 **09. Procedure for Dealing Cards from the Hand.**

17 A. If the cards are dealt from the dealer's hand, the following requirements shall be met:

18 (1) An automated shuffling device shall be used to shuffle the cards.

19 (2) After the procedures required under Regulation .05 have been completed, the dealer
20 shall place the stacked deck of cards in either hand, and

21 (a) After the dealer has chosen the hand in which to hold the cards, the dealer
22 shall continue to use that hand whenever holding the cards during that round of
23 play; and

24 (b) The cards held by the dealer shall be kept over the table inventory container
25 and in front of the dealer at all times.

26 B. Prior to dealing any cards, the dealer shall announce "no more bets."

1 (1) If the Progressive Payout Wager is being offered, the dealer shall use the progressive
2 table game system to prevent the placement of any additional Progressive Payout
3 Wagers.

4 (2) If any Progressive Payout Wagers have been made, the dealer shall:

5 (a) Collect the wagers;

6 (b) On the layout in front of the table inventory container, verify that the number
7 of value chips wagered equals the number of Progressive Payout Wagers accepted
8 by the progressive table game system; and

9 (c) Place the value chips into the table inventory container.

10 C. The dealer shall:

11 (1) Deal each card by holding the deck of cards in the chosen hand and use the other hand
12 to remove the top card of the deck and place it face down on the appropriate area of the
13 layout;

14 (2) Starting with the player farthest to the dealer's left and continuing around the table in
15 a clockwise manner, deal one card at a time to each player who has placed a wager in
16 accordance with Regulation .07 of this chapter and to the dealer until each player who
17 placed a wager and the dealer have three cards;

18 (3) Deal all cards face down; and

19 (4) After dealing three cards to each player and the dealer, except as provided in § D of
20 this regulation, place the stub in the discard rack without exposing the cards.

21 D. If an automated card shuffling device described in Regulation .05D of this chapter is not
22 being used, the dealer shall count the stub at least once every 5 rounds of play to determine if the
23 correct number of cards are still present in the deck by counting the cards face down on the
24 layout.

25 E. If the count of the stub indicates that 52 cards are in the deck, the dealer shall place the stub in
26 the discard rack without exposing the cards.

1 F. If the count of the stub indicates that the number of cards in the deck is incorrect, the dealer
2 shall determine if the cards were misdealt.

3 G. If the cards were misdealt but 52 cards remain in the deck, all hands are void and all wagers
4 shall be returned to the players.

5 H. If the cards were not misdealt, all hands are void, all wagers shall be returned to the players
6 and the entire deck of cards shall be removed from the table.

7 **10. Procedure for Dealing Cards from an Automated Dealing Shoe.**

8 A. If the cards are dealt from an automated dealing shoe, the following requirements shall be
9 met:

10 (1) After the procedures required under Regulation .05 of this chapter have been
11 completed, the cards shall be placed in the automated dealing shoe.

12 (2) If the Progressive Payout Wager is being offered, the dealer shall use the progressive
13 table game system to prevent the placement of any additional Progressive Payout
14 Wagers.

15 (3) If any Progressive Payout Wagers have been made, the dealer shall:

16 (a) Collect the wagers;

17 (b) On the layout in front of the table inventory container, verify that the number
18 of value chips wagered equals the number of Progressive Payout Wagers accepted
19 by the progressive table game system; and

20 (c) Place the value chips into the table inventory container.

21 B. The dealer shall:

22 (1) Deliver the first stack of cards dispensed by the automated dealing shoe face down to
23 the player farthest to the dealer's left who has placed a wager in accordance with
24 Regulation .07 of this chapter;

- 1 (2) As the remaining stacks are dispensed to the dealer by the automated dealing shoe,
2 moving clockwise around the table, deliver a stack face down to each of the other players
3 who has placed a wager in accordance with Regulation .07 of this chapter ;
- 4 (3) Deliver a stack of three cards face down to the area designated for the placement of
5 the dealer's cards; and
- 6 (4) After each stack of three cards has been dispensed and delivered in accordance with §
7 B of this regulation, remove the stub from the automated dealing shoe and, except as
8 provided in § D of this regulation, place the cards in the discard rack without exposing
9 the cards.
- 10 C. If an automated card shuffling device described in Regulation .05D of this chapter is not being
11 used, the dealer shall count the stub at least once every 5 rounds of play to determine if the
12 correct number of cards is still present in the deck by counting the cards face down on the layout.
- 13 D. If the count of the stub indicates that 52 cards are in the deck, the dealer shall place the stub in
14 the discard rack without exposing the cards.
- 15 E. If the count of the stub indicates that the number of cards in the deck is incorrect, the dealer
16 shall determine if the cards were misdealt.
- 17 F. If the cards were misdealt but 52 cards remain in the deck, all hands are void and all wagers
18 shall be returned to the players.
- 19 G. If the cards were not misdealt, all hands are void, all wagers shall be returned to the players
20 and the entire deck of cards shall be removed from the table.

21 **11. Procedure for Completing a Round of Play.**

- 22 A. After the dealing procedures required under Regulations .08, .09 and .10 of this chapter have
23 been completed, a player shall examine the player's cards subject to the following limitations:
- 24 (1) A player who wagers at Three Card Poker shall be responsible for the player's hand;
- 25 (2) No individual other than the dealer and the player to whom the cards were dealt may
26 touch a player's cards; and
- 27 (3) A player shall keep the player's three cards in full view of the dealer at all times.

1 B. After all players have examined their cards, beginning with the player farthest to the dealer's
2 left and moving clockwise around the table, the dealer shall ask each player who placed an Ante
3 Wager if the player wishes to make a Play Wager in an amount equal to the player's Ante Wager
4 or forfeit the Ante Wager and end the player's participation in the round of play.

5 C. If a player:
